AT LAST! THE FINAL PHOTOGRAPHIC PROOF

UFOs ARE REAL!

IT'S OFFICIAL: Visitors from beyond Earth are here – and they've been here for at least 61 years!

Now, a man who has been called a liar for most of his life may be vindicated to the tune of \$1 million for proving the "unprovable."

After years of controversy and heated debate, a chilling collection of photos, films and sound recordings of UFO activity have been proved authentic, causing red-faced cynics to eat their words.

For years, skeptics maligned humble Swiss farmer Billy Meier who claimed to have made contact with extraterrestrials

and documented UFOs in film and audio.

So-called experts dismissed Meier as a crackpot and a liar.

Scientific investigators including magician and noted scam de-bunker the Amazing Randi, science writer Michael Shermer and the Center For Inquiry (CFI) West all ruled Meier's exhaustive body of work as fraudulent.

Randi is so convinced that all UFO claims are false that he's offered a hefty \$1 million to anyone who can demonstrate the reality of anything "paranormal."

But Meier also has gathered a host of thoughtful supporters. Their own analyses convinced them Meier had captured the real thing.

Among them, a die-hard believer named Michael Horn.

Horn describes a 2001 meeting with Vaughn Rees, Projects Coordinator for CFI West in which the two of them reviewed Meier's 35mm photographs and 8mm movies.

"Mr. Rees promptly declared that the material was simply an 'easily documented hoax,'" Horn says.

He reports Rees was particularly contemptuous of the light effects on one UFO image. Rees reportedly told Horn that Meier created the effect by "scratching the film with a pin."

Horn issued a challenge: "Duplicate one of the photos using the same equipment Meier used."

Rees allegedly accepted the challenge.

But after several months with no reply from the respected investigator, Horn decided to make it easier for him.

"I invited him to forgo the cameras and use computers, digital effects, Photoshop, ANY technology he had access to in order to produce the items," he says.

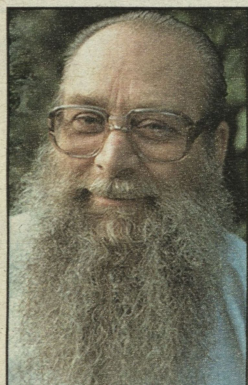
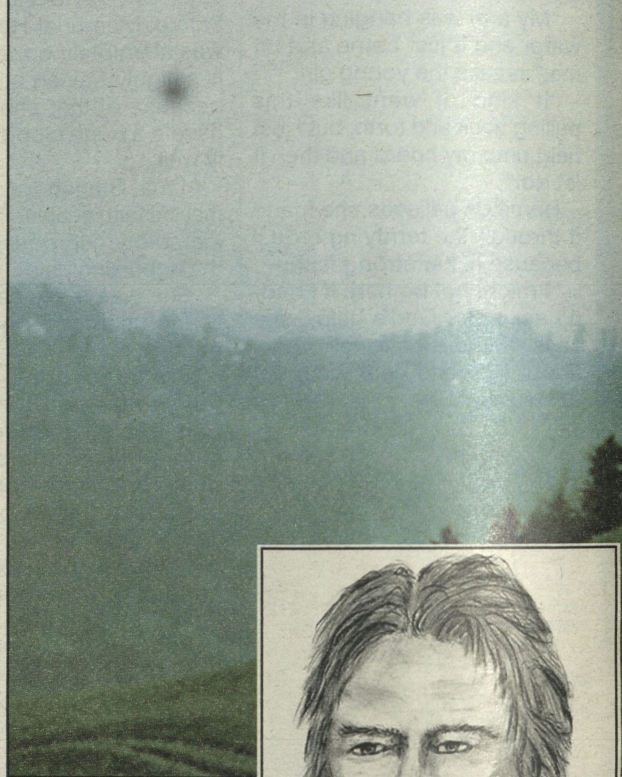
Almost two years has gone by and still Horn hasn't produced a single duplication or any other evidence that the photos were faked – even with the state-of-the-art techniques at his disposal.

Horn reports he also contacted Michael Shermer, a frequent contributor to Skeptic magazine, and the Amazing Randi, offering them an opportunity to disprove Meier's claim.

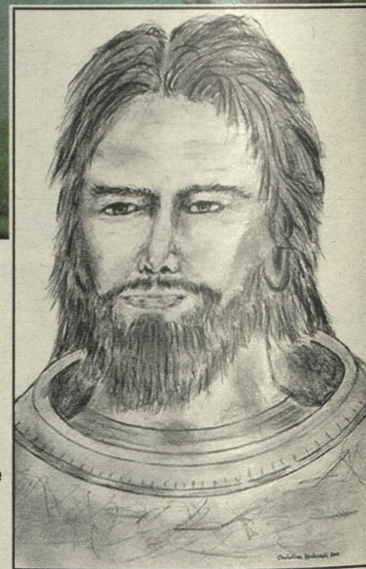
Neither could do so. Now Horn insists it's time for an apology.

"Mr. Rees and CFI West utterly and completely failed to meet the challenge they accepted," Horn says. "In doing so, they effectively proved Meier's UFOs real and their own claims unsubstantiated and defamatory."

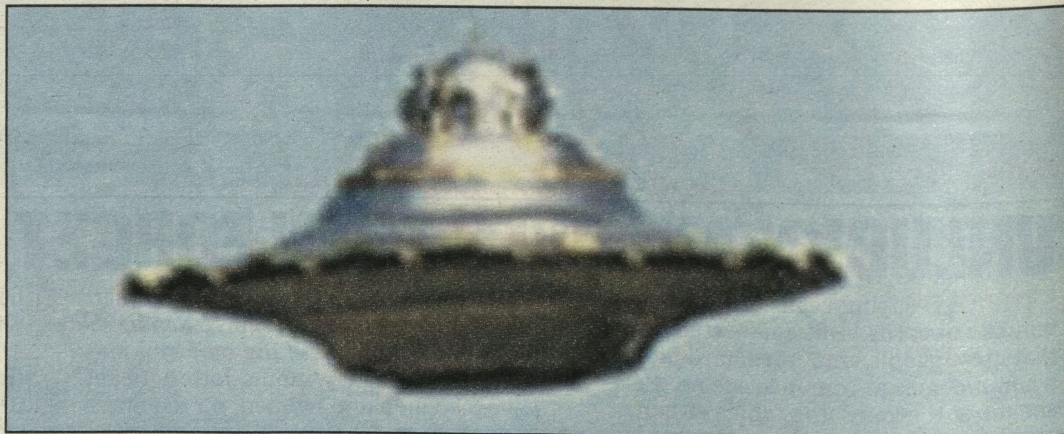
Rees and others also believe Meier deserves that \$1 million award from the Amazing Randi.

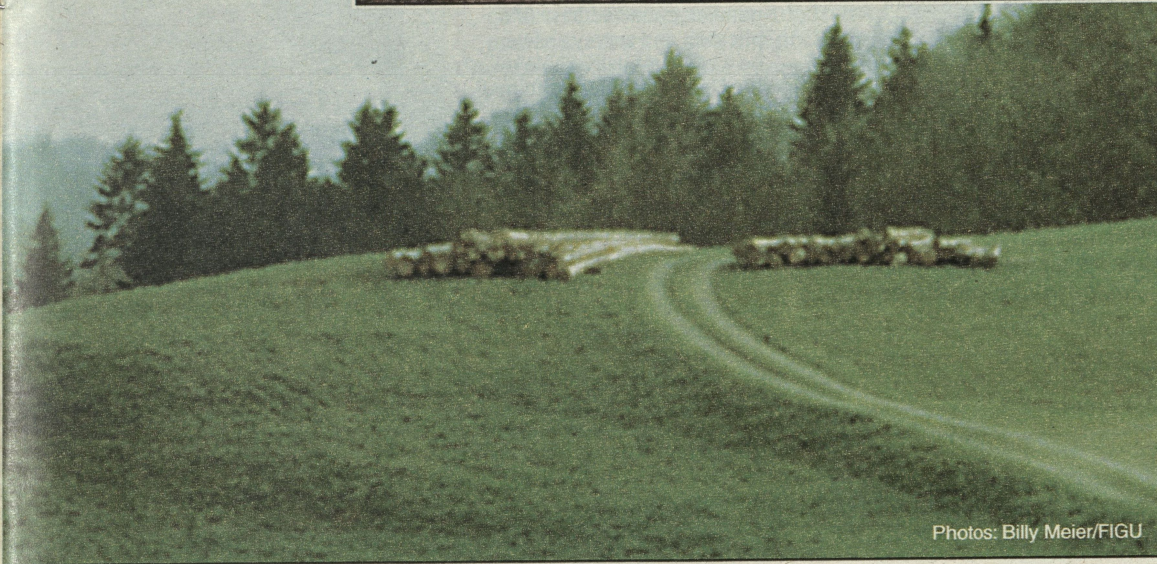


Meet the man with the evidence that stumped the doubters

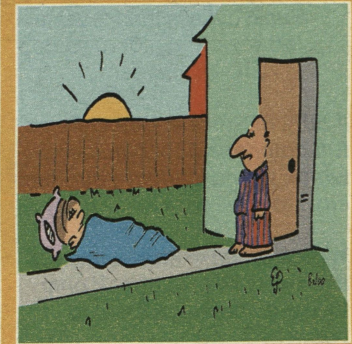
